RE: NELSON POOL SECURITY SYSTEM ALLOCATION

SUMMARY

Staff request to allocate up to \$11, 000 of the General Fund to install an upgraded security and camera system at Nelson Pool .

BUDGETARY IMPACT

As the Nelson Pool Project nears completion, staff is requesting the installation of the attached security system for both public safety and security reasons, including cameras be installed at facility. Monthly security monitoring expense is in the annual operating budget, installation expense will be paid from the general fund.

To better support the security system, staff has switched providers for internet service, both equipment and monthly internet service has been ordered and will be funded by the annual operating budget. Upgraded internet service is needed for aquatics programming, and will allow public to pay with credit cards at pool counter next season.

RECOMMENDATION

Approve the request allocation \$11k to install an upgraded security system at Nelson pool.

ALTERNATIVE OPTION(S)

Deny request and continue with current alarm system with limited coverage.
